- Nyob rau xyoo 2001, cov neeg Esia thiab cov neeg nyob rau cov tej laj lub tebchaws (xwm li Hawaii, Guam, Samoa, Fiji, Micronesia, Palau, Marshall Islands) txojkev siv yeeb tshuaj tabsi no mas qi heev, xwm li 2.8 feem pua, piv rau 7.2 feem pua yog cov neeg Amerrika dawb, 6.4 feem pua yog cov neeg Mev, 7.2 feem pua yog Amerrika Dub, thiab 9.9 feem pua yog cov neeg Khab ua ib txwm nyob lub tebchaws Amerrika puab thaum ub thiab cov neeg Alaskan ib txwm nyob Alaska tebchaws (SAMHSA, 2001).
- Tabsi no txojkev siv yeeb tshuaj uas txhaum cai nyob rau cov neeg uas nyob rau cov tej laj lub tebchaws (xwm li Hawaii, Guam, Samoa, Fiji, Micronesia, Palau, Marshall Islands) yog 5.1 feem pua, piv rau lwm haiv neeg lossis lwm pab pawg. Cov neeg Esia nyob rau sab qab teb thiab cov neeg Suav txojkev siv cov yeeb tshuaj mas nqi heev, nws yog nyob rau ntawd 2.5 feem pua thiab 1.3 feem pua (SAMHSA, 2001)
- Pib xyoo 1999 mus txog xyoo 2000, cov tub ntxhais hluas Esia (muaj noob nyoo 12-17 xyoo) thiab cov tub ntxhais hluas nyob rau cov tej laj lub tebchaws (xwm li Hawaii, Guam, Samoa, Fiji, Micronesia, Palau, Marshall Islands) txojkev siv cov yeeb tshuaj maj uas nyob lub hli dhau los poob ntawd 5.8 feem pua rau 2.5 feem pua. Tagnrho cov pab pawg neeg Esia, Filipino tub ntxhais hluas txojkev siv cov yeeb tshuaj maj uas nyob lub hli dhau los mas lawv siv ntau tshaj, xwm li 5 feem pua. Cov tub ntxhais hluas Nyivpoo txojkev siv mas nqi heev, xwm li 1.4 feem pua. Tagnrho, Nyablaj tub ntxhais hluas uas siv cov yeeb tshuaj maj no mas lawv siv ntau tshaj, xwm li 2.8 feem pua, twg yuav npaum li cov Amerrika Dawb, 2.9 feem pua (Prevention Alert. Vol.5, No.7, May 2001).
- Txawm yog cov neeg Esia thiab cov neeg nyob rau cov tej laj lub tebchaws (xwm li Hawaii, Guam, Samoa, Fiji, Micronesia, Palau, Marshall Islands), txojkev siv yeeb tshuaj qis heev tas li ntsuam xyuas nyob rau hauv cov pab pawg neeg. Cov tibneeg (uas niam thiab txiv tsis yog ib haiv neeg es sib yuav) txojkev siv mas siab heev, xwm li 12.6 feem pua uas ua rau cov neeg Esia thiab cov neeg Mev li ntsuam xyuas tsis yog tas li. (SAMHSA, 2001).
- Nyob rau xyoo 1994 mus txog xyoo 1999, cov neeg Esia thiab cov neeg nyob rau cov tej laj lub tebchaws (xwm li Hawaii, Guam, Samoa, Fiji, Micronesia, Palau, Marshall Islands) nkag mus txiav yeeb tshuaj yog nce nyob ze ntawd 52 feem pua (SAMHSA, 2001).
- Tagnrho cov haiv neeg, cov neeg Esia thiab cov neeg nyob rau cov tej laj lub tebchaws (xwm li Hawaii, Guam, Samoa, Fiji, Micronesia, Palau, Marshall Islands) cov tub ntxhais hluas feem coob es nkag mus txiav yeeb tshuaj yog raug xa mus xwb (The DASIS Report, 1999).
- Nyob ntawd cov pas tij ua tsis muaj leejtwg paub tabsi yog sib tham thiab paub xwm. Cov pas tij no nyob tom ntug dej hiavtxwv (San Francisco, Oakland) qaum teb California uas cov neeg siv cov yeeb tshuaj, cov tub ntxhais hluas Esia thiab cov tub ntxhais hluas nyob rau cov tej laj lub tebchaws (xwm li Hawaii, Guam, Samoa, Fiji, Micronesia, Palau, Marshall Islands) yog kwvlam mus li 25-35 feem pua, uas yog cov tuaj koom cov pas tij no (Nishioka, J. Asian Week, 2000).



- “E” los yog Ecstasy yog is yam yeeb tshuaj uas muaj koob muab npe tshaj nyob rau ntawd cov Suav uas yug ntawd Asmelikas tebchaw (Nishioka, J. Asian Week, 2000).
- Muaj coob leej tub ntxhais hluas siv cov tshuaj Ecstasy (MDMA), raw li muaj coob tus pom tau hais tais cov “E”no yog ib yam uas yooy yim yuav thiab siv yam tsis muaj leejtwg paub los pom (Nishioka, J. Asian Week, 2000).
- Fwm cov neeg muab hwjchim (tub ceev xwm los xibfwb qhia ntawv), kev ncaj nces rau yus tsev tibneeg, thiab yus lub hom phiaj yog kev mus kawm ntawv thiab kev kawm lwm yam yog ob yam ua uas rau kev pheed hmoo txojkev sib yeeb tshuaj nyob rau hauv cov neeg Esia thiab cov neeg nyob tej laj lub tebchaws (xwm li Hawaii, Guam, Samoa, Fiji, Micronesia, Palau, Marshall Islands).
